16 CAUTION - AIDS TO NAVIGATION

The buoyage in Puerto Rico, and the Spanish and US Virgin Islands is well laid out. However, the USCG buoy tender only comes down to check, repair and replace buoys and lights every six months. There is no local authority that maintains or replaces missing buoys. If a buoy goes adrift or a light goes out one month after the buoy tenders trip, it will not be replaced or repaired for five months. Thus the buoyage on this chart cannot be regarded as absolutely reliable. (ILNW 641/17)

MARINA PUERTO CHICO

Add new section below: SUN BAY MARINA

Sun Bay Marina was established in 2005/6 but not included in the chart printed in 2007 due to a lack of information

It is said that this is an excellent marina with 282 berths for boats up to 60ft in length and with up to 7ft draft. The marina offers all the normal services of a first class marina and is within walking distance of the village of Fajardo. The main town of Fajardo, meanwhile, is a taxi ride away.

There appear to be 7ft in the outer slip, with the basin shallowing as you get further in. The marina is normally full of Puerto Rican power boats leaving little room for visiting yachts except at weekends when the local boats disappear to neighboring islands
