3 **Port Erin Bay (Plan B)**

Insert limit of fishing prohibited area joining: 54°05'·15N 4°46'·30W (breakwater); 54°05'·55N 4°46'·78W (coast) and 54°05'·55N 4°47'·00W (edge of chart).

Delete former limit of fishing prohibited area between 54°05'·16N 4°47'·00W (edge of chart) and 54°05'·20N 4°46'·33W, and associated Lt buoy Fl.Y.5s. (ILNW 221/08)

4 **Port Erin Bay (Main chart)**

Insert limit of fishing prohibited area joining: 54°05'·15N 4°46'·30W (breakwater); 54°05'·55N 4°46'·78W (coast); 54°05'·55N 4°48'·08W; 54°04'·36N 4°48'·08W and 54°04'·36N 4°47'·20W (coast).

Add lgd (*Buoyed*) along western edge. Delete former limit of fishing prohibited area and associated Y Lt buoys. (ILNW 221/08)

5 **Peel (Plan A)**

Move Lt Fl.R.5s10m in 54°13'·44N 4°41'·76W to 54°13'·45N 4°41'·77W.

Insert ldg line from new Lt position, extending in direction 027·1°, and associated lgd *Ldg Lts 207·1°*.

Delete existing ldg line and associated lgd *Ldg Lts 204°*.

Delete sector at Lt Oc.R.7s8m5M in 54°13'·54N 4°41'·84W (ILNW 275/08)

Insert lgd *Works in Progress (2009)* centred on 54°05'·09N 4°35'·95W (ILNW 085/09)

Amend Ldg Lts Oc.10s12m5M to Oc.Bu.10s12m5M in:

8 **Point of Ayre**

Delete **Low Lt** Fl.3s10m8M in 54°25'·03N 4°21'·84W (ILNW 128/10)

9 **Bahama Bank**

Insert *A/S* at **Bahama Q(6)+LFI.10s** Lt buoy in 54°20'·03N 4°08'·59W (ILNW 145/10)

10 **Douglas (Plan E)**

Insert 2F.R Lt in 54°08'·87N 4°28'·34W, plus pontoon joining Lt to shore at 54°08'·87N 4°28'·38W. (ILNW 187/10)

11 **Approaches to Derbyhaven (Plan D)**

Works associated with the Ronaldsway Airport have been completed. Full details will be included on the next edition of this chart. (ILNW 491/10)

12 **Ramsey (Main chart & Plan F)**

Amend South Pier Lt to Iso.R.5s8m10M in 54°19'·43N 4°22'·50W [Iso.R.10M on main chart]. (ILNW 082/11)

13 **Chicken Rock**

Insert *Racon (C)* at Lt in 54°02'·27N 4°50'·31W (ILNW 281/11)

14 **Chicken Rock**

Amend range of Lt at Chicken Rock to 20M in 54°02'·27N 4°50'·32W. (ILNW 202/15)

15 **Ballacash Bank**

Insert YBY West Pillar Lt buoy VQ(9)10s in 54°26'·50N 4°16'·70W (ILNW 30/16)

16 **Douglas (Plan E)**

Delete G sector at Lt Iso.G.10s in 54°08'·84N 4°28'·08W (ILNW 416/17)

17 Maughold Hd

Amend range of Lt FI(3)30s65m21M to 15M in 54°17'·72N 4°18'·56W (ILNW 471/18)

18 Douglas Head (Main chart & Plan E)

Amend range of Lt FI.10s32m24M to 15M in 54°08'·59N 4°27'·95W (ILNW 479/18)

19 Port Erin W

Insert Y special pillar Lt buoy with x topmark FI(5)Y.20s plus racon sym. & assoc. lgd A/S in 54°05'·79N 4°50'·01W (ILNW 209/23)
