1 **Isola di San Pietro N**

Delete *No entry* restricted area centred on 39°10'·00N 8°14'·50E (ILNW 541/20)

2 **Golfo di Cagliari TSS**

The extents to the TSS centred on 39°07'·90N 9°04'·30E have changed.

Move the magenta traffic separation line between:

39°08'·27N 9°03'·71E

39°07'·57N 9°04'·92E

to:

39°08'·45N 9°04'·54E

39°09'·00N 9°03'·62E

Move the inbound and outbound arrows accordingly (ILNW 169/21)

3 **Capo S. Lorenzo N**

Rocks and shoal water extend for some distance off the coast between Torre Murtas (39°33'·12N 9°39'·04E) and Isola di Quirra (39°31'·48N 9°39'·64E) to Capo S. Lorenzo (39°29'·42N 9°38'·79E) which are not shown at chart scale. Yachtsmen are advised to proceed with caution (ILNW 438/21)

4 **Golfo di Teulada**

The restricted area around Capo Teulada has changed. Insert restricted area limit, no anchoring, no fishing, no diving joining:

38°51'·5N 8°39'·0E (existing limit)

38°53'·8N 8°42'·1E

38°55'·1N 8°42'·2E (coast)

Delete existing restricted area limit between 38°55'·4N 8°42'·7E (coast) and 38°51'·5N 8°39'·0E (existing limit)

Delete no anchoring sym in 38°54'·4N 8°42'·3E (ILNW 96/22)

5 **Golfo di Teulada (Plan F)**

The restricted area around Capo Teulada has changed. Insert restricted area limit, no anchoring, no fishing, no diving joining:

38°51'·96N 8°37'·86E (W extent of plan)

38°51'·50N 8°39'·00E

38°53'·80N 8°42'·10E

38°55'·13N 8°42'·15E (coast)

Insert Igd *Explosives* (see *Note*) centred on 38°53'·90N 8°40'·80E

Delete existing restricted area limit between 38°55'·36N 8°42'·60E and 38°51'·93N 8°37'·86E (ILNW 96/22)

6 Canale di San Pietro (Plan C)

Delete:

Y special spar buoy in 39°10'·12N 8°20'·01E

BY N cardinal can buoy in 39°09'·09N 8°20'·38E

Y special con buoy in 39°08'·07N 8°20'·06E (ILNW 97/22)

7 Isola Piana SE (Plan C)

Delete circular anchorage area/fishing prohibited area centred on 39°10'·68N 8°20'·00E (ILNW 183/22)
