There have been numerous changes to the restricted areas around the entrance to Çanakkale Boğazi.

Between Taşlı Br. 39°58'·20N 26°10'·30E and 40°00'·21N 26°13'·75E, extending 1000m seawards from the coast, unauthorised entry of foreign flagged vessels is prohibited.

Extend limit of anchoring and fishing prohibited area N from 39°58'·15N 26°09'·37E to Tekke Br. in 40°03'·16N 26°09'·94E

Delete label *Anchoring, Fishing Diving and Landing Prohibited* centred on 40°01'·10N 26°08'·50E plus assoc. restricted area limit. (ILNW 552/18)

19 Saros Körfezi

Delete circular restricted area and assoc label *Explosive* (see Note) centred on 40°36'·2N 26°37'·1E. Delete assoc chart note. (ILNW 129/23)

20 Kale Limani W, Saros Körfezi

Insert Lt 2Mo(U)10s10M in 40°38'·10N 26°39'·20E (ILNW 317/23)

21 Alexandroupolis SW

Insert moored vessel **Alexandroupolis** in 40°45'·7N 25°42'·8E enclosed by circular limit of restricted area radius 1000m. (ILNW 300/24)

22 Çanakkale Boğazi

The Çanakkale Boğazi bridge joining 40°20'·94N 26°37'·12E and 40°19'·80N 26°39'·40E is complete. Insert solid lines joining above points and delete pecked linework. Replace lgd Bridge under construction (2018) with Çanakkale Bridge. Add clearance height 70m (ILNW 365/24)

23 Nara Geçidi (Plan D)

Insert lgd *Shellfish Beds* (see Note) in 40°12'·03N 26°25'·75E

Add note:

SHELLFISH BEDS

Avoid anchoring or grounding in areas of shellfish beds (ILNW 366/24)

24 Entrance to Çanakkale Boğazi (Plan C)

Insert Y spar buoy with x topmk in 40°02'·85N 26°07'·28E

Move Y spher Lt buoy FI(5)Y.20s in 40°02'·64N 26°02'·17E to 40°02'·38N 26°02'·25E (ILNW 18/25)
